

میری پارٹی سے فروری کا لیکشن اور عوامی مینڈیٹ چھینا گیا: عمران خان



اسلام آباد// پاکستان کے سابق وزیر اعظم عمران خان نے ڈیلیٹیل سے ویڈیو لنک پر سہرم کورٹ میں نیب قوانین میں حالیہ تبدیلیوں کے خلاف اپیلی کی سماعت کے دوران ملک کی اعلیٰ ترین عدالت کے سامنے میڈیا لکشن چوری کا الزام لگایا ہے۔ انہوں نے کہلا عوامی مینڈیٹ کے ساتھ اب تک کی ڈیلیٹیل تھی۔ سابق وزیر اعظم عمران خان پچھلے تقریباً ایک سال سے قید میں ہیں۔ انہیں گزشتہ دو برسوں میں حکومت کی طرف سے بیسیوں مقدمہ کا سامنا رہا ہے۔ اس لیے ایک مقدمے میں دھریے جاتے رہے ہیں۔ یہی حال ان کی جماعت کے کئی رہنماؤں کے ساتھ کیا گیا ہے۔ تاہم سہرم کورٹ نے ان کی دائر کردہ ایک اپیل پر سماعت مقرر کی تو ججیل بار انہیں ویڈیو لنک کے ذریعے اپنا موقف بیان کرنے کا عوامی سطح پر موقع مل گیا۔ عمران خان نے کہلا فروری کے عام

انتخابات میں انسانی حقوق کی انتہائی خلاف ورزی روا رکھی تھی۔ ان کی سیاسی جماعت کو اس کے سیاسی حقوق سے بھی محروم کر دیا گیا اور انہیں انتقام کا نشانہ بنایا گیا۔ اس صورت حال میں ان کے بقول انہیں فوجی شناخت کے سب سے اہم شہر راولپنڈی کی ڈیلیٹیل میں قید تہائی میں رکھا گیا ہے۔ واضح رہے انتخابی عمل میں پاکستان تحریک انصاف سے انتخابی نشان چھپنے جانے کے باوجود عمران خان کی جماعت سب سے بڑی جماعت کے طور پر سامنے آئی۔ اس مقدمے کی سماعت کرنے والے جج کی سربراہی چیف جسٹس قاضی فائز عسیٰ خود کر رہے ہیں۔

غزہ// رفح میں اسرائیلی فوج کے بے درپے حملوں کے بعد کوئی علاقہ بھی محفوظ نہ رہا۔ غیر ملکی خبرسرا ادارے کے مطابق اسرائیلی فوج نے رفح کے سمخان آباد علاقوں میں حملے تیز کر دیے ہیں۔ اسی دوران پیش قدمی کرتے ٹینک رہائشی عمارتوں پر گولہ باری کرتے چارے ہیں۔ اسرائیلی فوجیوں نے رفح کے گنجان آباد علاقوں میں ایکسپنشن پر م مارکر ریسکیو کارروائیوں میں شریک 2 ہلاکوں کو قتل کر دیا جب کہ اسرائیل کے حملوں میں مزید 37 فلسطینی شہید ہوئے۔ اسرائیلی حملوں میں شہید ہونے والے بیشتر افراد خیموں میں مقیم تھے۔ امدادی گروپ سیو دی پائلرز کا کہنا ہے کہ عالمی عدالت کے حکم کے بعد تقریباً ایک ہفتے میں اسرائیل نے رفح کے محفوظ قرار دیے علاقوں میں حملے کیے جس میں 66 فلسطینی جان سے گئے جن میں بچے اور خواتین بھی شامل ہیں۔ امدادی گروپ نے رفح اور غزہ کی پٹی میں خواتین اور بچوں سمیت عام شہریوں کے قتل عام پر فوری کارروائی کا بھی مطالبہ کیا ہے۔ اسرائیلی فوج نے دعویٰ کیا ہے کہ اس نے مصر کے ساتھ غزہ بارڈر کی پوری پٹی پر کنٹرول حاصل

ایران کا ریسی کی جگہ پُر کرنے کی غرض سے صدارتی انتخابات کیلئے رجسٹریشن کا آغاز

تہران// ایران نے مرحوم صدر ابراہیم رئیسی کی جگہ پُر کرنے کی غرض سے 28 جون کو ہونے والے صدارتی انتخابات میں شرکت کے خواہشمند امیدواروں کے لیے جمعرات کو پانچ روزہ رجسٹریشن کا آغاز کر دیا ہے۔ رئیسی اسی ماہ کے وسط میں تہلی کا پہلے کے حادثے میں سات دیگر افراد کے ساتھ ہلاک ہو گئے تھے۔ یہ انتخابات ایسے وقت میں ہو رہے ہیں جب ایران 19 مئی کے حادثے کے نتائج تیز تہران اور ریاست ہائے متحدہ کے درمیان بڑھتی ہوئی کشیدگی اور مظاہروں سے نمٹنے کے لیے کوشاں ہے جن میں 2022 میں نوجوان خاتون مہسا امینی کی زیر حراست موت پر ہونے والے مظاہرے بھی شامل ہیں جنہوں نے پورے ملک کو اپنی لپیٹ میں لے لیا ہے۔ جبکہ ریاست کے تمام معاملات میں اعلیٰ ترین راہنما 85 سالہ آیت اللہ علی خامنہ ای کی رائے حتیٰ درجہ رکھتی ہے، ماضی میں صدور نے اسلامی جمہوریہ ایران کا جھکاؤ مغرب کے ساتھ

چینی صدر کا مشرق وسطیٰ پر بین الاقوامی امن کانفرنس بلائے کا مطالبہ بیجنگ// چین کے صدر شی جن پنگ نے آج جمعرات کو بیجنگ میں چین۔ عرب تعاون فورم کے افتتاحی اجلاس کے موقع پر عرب ممالک کے ساتھ اپنے "گہرے تعلقات" کو خوش آئند قرار دیا۔ انہوں نے چین اور عرب ممالک کے درمیان تعاون کو مزید وسعت دینے پر زور دینے کے ساتھ ساتھ مشرق وسطیٰ پر بین الاقوامی امن کانفرنس کے انعقاد پر زور دیا۔ چینی صدر کے خطاب کے موقع پر چار عرب ممالک مصر، متحدہ عرب امارات، بحرین اور تونس کے سربراہان اور وزرائے خارجہ بھی موجود تھے۔ صدر شی جن پنگ نے اپنے خطاب میں کہا کہ "جب بھی میں اپنے عرب دوستوں سے ملتا ہوں، مجھے اپنائیت کا گہرا احساس محسوس ہوتا ہے۔" انہوں نے مزید کہا کہ "چین اور چین خوام اور عرب ممالک اور عوام کے درمیان وقت قدیم اور طویل شاہ اور ریشم کے ساتھ دوستانہ تعلقات کے تبادلے سے پیدا ہوئی ہے۔" انہوں نے مزید کہا کہ چین اور عرب ممالک اقتصادی اور تجارتی تعلقات کے لیے زیادہ متوازن فریم ورک بنائیں گے جس سے دونوں فریقوں کو فائدہ پہنچے گا۔ غزہ کی جنگ کے حوالے سے چینی صدر کا کہنا تھا کہ جنگ غیر معینہ مدت تک جاری نہیں رہ سکتی۔ انصاف مستقل طور پر غائب نہیں رہ سکتا اور درواری حلی کو من مانی پر نہیں چھوڑا جاسکتا۔ انہوں نے کہا کہ "چین مکمل خودمختاری کے ساتھ ایک آزاد فلسطینی ریاست کے قیام کی بھرپور حمایت کرتا ہے اور فلسطینیوں کی اقوام متحدہ میں مکمل رکن ریاست بننے کی کوشش کی تائید کرتا ہے۔"
